## **RESOLUTION 03/2014**

## of the Board of the Foundation for Health Protection in Dąbrowa Górnicza of January 23, 2014

Taking into consideration remarks of the beneficiaries, the Board of the Foundation for Health Protection changes the rules concerning drug refunds:

 Employees supporting the Foundation, their families (i.e. their spouses and dependent children in school age) as well as old age pensioners and employees on disability pension are entitled to a refund for drugs purchased in the pharmacy "Z Sercem" amounting to:

50 % of the drug cost, provided that the amount exceeds PLN 50.

- Drugs can be purchased in a pharmacy other than the pharmacy "Z Sercem" (in special cases) in which case a refund amounts to:
  25 % of the drug cost, provided that the amount exceeds PLN 50.
- 3. A refund for rehabilitation equipment included in the list of equipment refunded by the National Health Fund (NFZ) refers to standard quality equipment indicated by a medical specialist. The costs are refunded after obtaining subsidies from other sources, e.g. State Fund for Rehabilitation of Disabled Persons (PFRON), National Health Fund (NFZ), Municipal Social Welfare Center (MOPS).

A refund for the entitled individuals supporting the Foundation amounts to:

50 % of the rehabilitation equipment costs, not more however than PLN 500.

- 4. A refund applies to vaccines and prescription medications.
- 5. The group of refunded drugs is extended to include medications for joints and bones, enlarged prostate gland, menopause, eyes, digestive track diseases, painkillers.
- 6. A refund does not apply to:
  - cosmetics, dressings, personal care products, food supplements; parapharmaceuticals, dietary supplements slimming products, contraceptives;

- glasses, blood pressure monitors, air humidifiers, inhalers, dental braces, specialist enhancing devices, equipment distributed by companies which do not specialize in supplying medical devices (e.g. Zepter).
- posture correction exercises for children; cosmetic surgeries and procedures, beauty treatments; dental procedures, orthodontic procedures; tests related to procedures, infertility treatment and in vitro fertilization.
- 7. Each time the entitled person is obliged to submit an request prior to buying a drug, having an test/examination, purchasing equipment. The request will be carried out after gaining approval of the Foundation for Health Protection.
- 8. Only prescriptions specified in the request whose date matches the date of confirmation given by the Foundation Office, as indicated on the other side of the prescription, will be accepted. Requests for statutory help accompanied by invoices which were issued prior to the date of submitting the said request, that is the ones which were carried out before the Foundation Office made a decision, will not be considered.
- 9. Refunds for drugs and rehabilitation equipment will be transferred to the personal bank account indicated by the entitled persons.
- **10.** Requests for a **100** % refund as part of statutory help offered by the Foundation of Health Protection will be examined only in random events **associated with accidents at work**.

Provisions of this Resolution become effective as of March 1, 2014.
